**MAGISTERIAL DECREE 05 / 2018**

To all Dames and Knights, Brethren of  
Our Sovereign Order of Saint John of Jerusalem  
Knights of Malta  
Federation of Autonomous Priors,  
let it be known by the present letters that

We, José, by the Grace of God Hereditary Regent and Grand Chancellor of the Sovereign Order of Cyprus, Hereditary Grand Prior and Procurator General of the Grand Priory of the Most Holy Trinity of Villedieu and, by the Will of Our fellow Knights, Prince Grand Master and Head of State of the Federation of Autonomous Priors of the Sovereign Order of Saint John of Jerusalem, also said of the Knights Hospitallers or of Malta, in virtue of the powers bestowed upon Us, namely the by the Articles n° 1 and n° 2 of Chapter III and of the Chapter VII of Our Constitutional Letter;

Having considered the urgent need of appointing a new International President for the Chamber of Commerce, Industry, Agriculture and Services of our State, created on the 27<sup>th</sup> of August of 2007 by Our Magisterial Decree number 27/07;

Having considered the professional career as a very well succeeded and respected international Businessman, the competence, the very high moral principles and exemplary personal values of the Knight appointed hereinafter by the present Decree, who is well known to Us;

After having consulted with the competent Governmental bodies in accordance with the Article 8<sup>th</sup> of the Chapter VII of Our Constitutional Letter;

having had all the above stated facts in consideration and, in accordance with all the Articles of Chapter II and the Articles nr.° 2, nr.° 3, n° 4 and nr° 8 of the Chapter VII of Our Constitutional Letter, and with the regulations stipulated by the Article 1 b) and 3 b) of Our Magisterial Decree number 06/2009 regarding our Chamber of Commerce, Industry and Services of our State;

**We come to decree and We do decree:**

**ARTICLE 1.** By the present Decree We appoint

ARTICLE 2. The International President of Our Chamber of Commerce, Industry and Services, in accordance with the Article 5 of Our Magisterial Decree n° 02/18, has the rank equivalent to Minister and has permanent sit in the Ministerial Chamber of the Government of our State.

ARTICLE 3. The new of President of the Chamber will report solely and directly to Us in Our capacity as Chief of State and President of the Government and to Our Prime Minister as Vice President of the Government.

ARTICLE 4. The present Magisterial Decree is effective from this day on.

This decree, was given in two ( 2 ) pages, at Our Grand Magisterial House this 11<sup>th</sup> day of the month of April of the year of our Lord 2018 and to it We have hereunto set Our hand and the seals in use at this House .
